## **EXPECTATIONS FOR ALL PARTICIPANTS**

God loves and cherishes each of us, therefore, we will seek to do nothing but love and cherish each other while at Camp Christian. Consequently, insults, peer pressure, name-calling, ethnic/ racial/ sexual jokes, fighting, sexual abuse, harassment, stealing, inappropriate language, inappropriate public or private displays of affection, will NOT be tolerated. Our bodies are temples of the Holy Spirit, therefore, we will not mutilate them, use illegal drugs, alcohol or tobacco... nor will we misuse/abuse prescription drugs. Ignoring these expectations will result in your being sent home for the safety of the camp community. Life is precious, so we will do nothing to jeopardize our own safety, or that of others. We will, further, respect the order created for our safety by Camp Christian: NO swimming in the lake, NO leaving camp boundaries, NO use of cars during camp, NO hover boards, NO weapons or intentional damage of camp property, NO graffiti and NO littering. Our goal is to build a community that as perfectly as possible reflects the realm of God on earth. Therefore, we will not use distracting electronic devices or wear inappropriate attire while at Camp Christian, and will not participate in behavior that is disrespectful of the entire community.

- Ribbit Camp, Otter Camp, Chi Rho Camp, Camp Encore, Created to Be Me, - Cell phones are not permitted and will be collected at registration.
- All Campers, Counselors, Directors and Staff are expected to use good judgment in their personal appearance and dress. Camp dress should be such that it ensures the health, welfare, and safety of the members of the Camp. At no time should dress and grooming be such that it detracts from the camp experience. The following are examples of items which are NOT acceptable for camp:

### **Clothing**

1. Sleeveless shirts, tops, and dresses with shoulder straps less than two inches (the height of a driver's license or credit card)
2. Bare midriffs, cleavage, halter tops, tank tops, shirts that are off the shoulder and clothing that is see through. No undergarments or straps should be visible.
3. All pants MUST be worn at the waistline and must fit properly to stay at the waist with or without a belt.
4. Writing on clothing, which promotes drugs/alcohol, contains suggestive dual meanings or contains vulgar slogans/language.
5. Ragged clothes-holes in jeans may not be above figure tips when arms are hanging at sides. NO undergarment may show.
6. Skirts, dresses, or shorts shorter than the campers fingertips with arms hanging naturally at the side.
7. Leggings or tights that are see through without a dress, shirt, or top that is fingertip length.
8. Pajamas (during the day)
9. Shirts that are not long enough to be tucked in at the waist line.
10. Extremely wide leg or long pants that hang on floor are a safety problem.
11. Pants with straps that hang or dangle from the pants that could get caught on items are a safety problem.
12. Foot ware-bare foot, socks only, or slippers throughout the camp.
13. Covering Face with Hats, Caps, Head Scarves/Bandanas, Hoodies.
14. Dark Glasses/Sunglasses unless prescribed by a doctor while indoors.
15. Accessories-Students are unable to wear safety pin necklaces or ear rings, spike bracelets or sharp/pointed accessories, and any type of chain (including ones attached to clothes or wallets).

You are expected to abide by all camp rules. If you do not conduct yourself in a proper Christian manner, the Directors, Regional Staff, or Regional Staff Designee have the right to send you home.

Do not be late for activities, use any electronic devices, enter the space of others uninvited or the personal space of anyone anytime, or entertain visitors at camp during the week. Clothing promoting sex, drugs, tobacco or alcohol are considered inappropriate. Because we are children of God, and are here to learn about and worship God, we honor our times of worship and prayer, and respect the quiet times of others, such as Vespers, Morning Watch, Taps and Consecration.

**Bullying:** Any camper found to be harassing, making fun of, or intimidating another camper is subject to disciplinary actions and may be sent home.
